Texas Swedish Pioneers Association Elects Its First Woman President

The Board of Directors of the Texas Swedish Pioneers Association (TSPA) elected its first woman president in its 93-year history. Elizabeth "Liz" Jean Sellstrom Cadwallader, a former Swedish Club of Houston member whose ancestors include the Stark, Sellstrom, and Quist families of Round Rock and Austin, was named the new President at a board meeting in February, 2010.



President Cadwallader, who has a deep interest in Texas Swedish history and traditions, hopes to continue the vital work of the association. She states, "I have traveled twice to Sweden with my family. I have a special interest in Swedish folk dresses and Swedish

traditions. I am excited and honored to be the new President of the Texas Swedish Pioneer Association." Liz is picturered here in a traditional Swedish dress.

In 1917 the Texas Swedish Pioneers Association held its first celebration in honor of the 50th anniversary of the arrival of 100 Swedes who came to Texas in 1867. The first Swede to arrive in Texas was S. M. Swenson, who came to Texas in 1838. He was joined by his uncle, Sir Svante Palm, who played an important role in early Austin history.

The purpose of TSPA is to preserve and perpetuate the rich Swedish heritage and to honor the memory of Texas Swedish Pioneers. During the period 1870-1910, some 10,000 Swedes settled in Travis, Williamson, and Bastrop counties, where they built homes, churches, businesses and farms. Some 20 churches in the Austin area trace their origins to the Texas Swedish pioneers. Swedish place names today dot the Austin area landscape (such as Govalle, Palm, Berkman, Linder, and Widen public schools), facilities (such as Bergstrom Airport, Palmer Auditorium, and the Falk baseball field), roads (Anderson Lane, Rundberg Lane and Berkman Drive), commercial ventures too many to mention, but including the Nelson store in Round Rock, the Seaholm Power plant, and communities (Palm Valley, New Sweden, and Lund to mention a few).

The TSPA through the years has been active in the preservation of Texas Swedish landmarks such as the Swedish Log Cabin and blacksmith shop at the Zilker Garden Center. In 1965, the association arranged for the log cabin, which had been located at Govalle and then moved to Round Rock, to be moved back to Austin.

In the early 1990s members of the TSPA participated in the monumental translation project that translated from Swedish into English the 1200-page book known as *Swedes in Texas In Words and Pictures*, published in 1918.

In Memoriam Gudrun Merrill

Former Swedish Club member Gudrun Wallgren Merrill died April 6, 2010, at the age of 86. She is survived by her husband Dr. Joe Merrill, daughters Maria Merrill and Caroline Cooley, son-in-law Smith Cooley and grandchildren, Annabelle and Holden Cooley.

In addition to many other volunteer and civic positions, Gudrun served as the first President of SWEA of Texas. She was also a Board member of the Swedish-American Chamber of Commerce and Linneas of Texas. In 1996 Gudrun worked with the committee that established an Endowment for Swedish Studies at the University of Texas in Austin. In 1998 she received the Swedish Council of America's Award of Merit in recognition 'of service toward preservation and promotion of Swedish heritage in America.'

News from Sweden (from Swedish Council of America's March, April and May 2010 *eUPDATE*s)

→ Swedish researchers, together with their Lao colleagues, have discovered a previously unknown bird species in southeast Asia. The new species, named *Phylloscopus calciatilis*, is related to the willow warbler, but lives only in areas of limestone rock.

→ Swedish top flight football club, Brommapojkarna (BP), has introduced a language policy requiring all players to speak Swedish to each other in order to be eligible for selection. BP chairperson Ola Danhard confirmed that the club's board had voted to establish a policy for the exclusive use of Swedish within the club, both in its changing rooms and on the pitch. "It is important for the collective that everyone in the team speaks the same language," he said.

→ Two Swedes have been named among the richest people in the world, according to the latest Forbes ranking which ranks Mexican Carlos Slim in first place. Slim is worth a purported \$53.5 billion while Bill Gates has to make do with \$53 billion, followed by U.S. investor Warren Buffet on \$47 billion. The first Swede on the list is Ikea founder Ingvar Kamprad in 11th place. The Kamprad family fortune amounts to \$23 billion. The richest Swedish resident is Stefan Persson of clothing chain H&M, in 13th place with \$22.4 billion.

→ A number of maritime treasures off Sweden's southern coast are under threat from the shipworm, which is gaining a foothold in the Baltic Sea due to climate change, according to researchers at the University of Göteborg. Traditionally, shipworms have avoided the Baltic Sea due to its lower salt content. The Baltic therefore holds a number of archaeological finds featuring wrecks of wooden ships and structures which would not likely have survived were it not for the mild salinity levels of Baltic waters.

→ Stockholm-Arlanda airport is considering the introduction of a 100 kronor (\$14) toll for cars entering the terminal area in a bid to reduce carbon dioxide emissions, Stockholm daily *Dagens Nyheter* reports. The move comes as the airport struggles to meet its current emissions targets. Since flight

emissions are almost impossible for a single airport to limit, the airport is instead mulling over the option of trimming its emissions through a reduction in car traffic.

→ The head of the Swedish Work Environment Authority (Arbetsmiljöverket) has raised the prospect of a ban on cash in Sweden's retail stores to help tackle the growing problem of robbery. The authority's director-general, Mikael Sjöberg, refused to rule out the drastic measure in an interview recently.

→ The Swedish postal service, Posten, and Sweden's central bank, the Riksbank, have unveiled new stamps and coins commemorating the wedding of Crown Princess Victoria and Daniel Westling on June 19th. The three stamps include portraits of both the princess alone and of the royal couple, as well as one with a crown and the royal couple's monogram. The Riksbank will issue two commemorative coins for the wedding: a 300 kronor (\$40) silver coin and a 4,000 kronor (\$525) gold coin.

→ The June 19, 2010, wedding of Crown Princess Victoria and Daniel Westling is set to cost at least 20 million kronor (\$2.63 million), half of which will be met by the bride's father, King Carl XVI Gustaf, with the remainder funded by the Swedish taxpayers. "We get ten million kronor from the government and the rest will be paid for by the king personally," said Jan Lindman at the Royal Court. The Royal Court will receive a total of 125 million kronor from the Swedish taxpayers for 2010, eight million more than in 2009.

Voting in Swedish Elections

Swedes living abroad remain in the electoral register, and thereby maintain their right to vote, for ten years after their emigration is officially recorded in the national register.

After 10 years, a written notification must be submitted to the Swedish National Tax Board (Skatteverket) to retain the right to vote for an additional ten year period. See the form at

www.val.se/det_svenska_valsystemet/rostratt/utlandssven skar/index.html.

The completed notification form must be received by the National Tax Board at least 30 days before the election date. The form must be mailed to the National Tax Board at the following address:

If the notification has not been received 30 days before the election date, Swedes abroad who are not in the electoral register may still have the opportunity to vote. A vote received from abroad by mail or by a Swedish foreign mission will still be counted, if it has reached the Election Authority by 12:00 pm on the day before the election. To avoid unnecessary searches, and to reduce the worry among your family and friends in Sweden, the Embassy advises all Swedish travelers in the U.S. to immediately contact your loved ones back home and let them know what your situation is.
